MANAGEMENT'S DISCUSSION & ANALYSIS

For the six months ended February 28, 2025

This management's discussion and analysis of financial position and results of operations ("MD&A") is prepared as at April 15, 2025 and should be read in conjunction with the unaudited condensed interim financial statements for the six months ended February 28, 2025 of Grosvenor Resource Corporation ("Grosvenor" or the "Company") with the related notes thereto. Those unaudited condensed interim financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS") for interim financial statements and, as a result, do not contain all disclosure required under IFRS for annual financial statements. Accordingly, readers may want to refer to the August 31, 2024 audited annual financial statements and the accompanying notes.

Management is responsible for the preparation and integrity of the financial statements, including the maintenance of appropriate information systems, procedures and internal controls. Management is also responsible for ensuring that information disclosed externally, including the financial statements and MD&A, is complete and reliable.

All dollar amounts included therein and in the following MD&A are expressed in Canadian dollars except where noted. Description of Business

Grosvenor is a natural resource company engaged in the acquisition and exploration of resource properties. The Company's head office is located in Vancouver, British Columbia. The Company is a reporting issuer in British Columbia, Alberta, Ontario and Nova Scotia. Grosvenor trades on the TSX Venture Exchange ("TSX-V") under the symbol GVR.

Overview

Powder

In 2018, the Company acquired a 100% interest in the Powder gold-silver property for \$7,500 and 50,000 of its common shares (valued at \$8,500). To date, the Company has paid a total of \$30,482 in claim maintenance. During the year ended August 31, 2024, the Company made the decision to impair the property to \$1. The property is subject to a 1% NSR, and the claims remain in good standing.

Results of Operations

During the three months ended February 28, 2025 ("current period") the Company recorded a comprehensive loss of \$60,999 compared to \$516,791 for the three months ended February 29, 2024 ("comparative period"). The significant changes during the current period from the comparative period are as follows:

- The Company recorded a deferred tax recovery of \$4,893 on a marketable securities gain during the current period, compared to an expense of \$62,378 on a marketable securities loss during the comparative period.
- The Company recorded an unrealized marketable securities gain of \$16,887 during the current period, compared to a loss \$399,682 during the comparative period. The change relates to the value fluctuation of Newport Exploration Ltd (“Newport”) common shares held by the Company.
- During the comparative period, the Company recorded dividend income of \$27,180 or \$0.005 per share of the Company’s Newport shareholders. No dividend income was recorded during the current period.

During the six months ended February 29, 2025 (“current six-month period”) the Company recorded comprehensive loss of \$385,153 compared to \$578,594 for the six months ended February 29, 2024 (“comparative six-month period”). The significant changes during the current six-month period from the comparative six-month period are as follows:

- During the comparative six-month period, the Company recorded dividend income of \$81,540, or \$0.015 per share of the Company’s Newport shareholdings. No dividend income was recorded during the current six-month period.
- During the current six-month period, the Company recorded a deferred tax expense of \$39,139 on a marketable securities loss, compared to \$69,717 in the comparative six-month period.
- During the current six-month period, the Company recorded an unrealized marketable securities loss of \$183,701, compared to \$441,303 in the comparative six-month period. The change relates to the value fluctuation of marketable securities held by the Company.

Liquidity and Capital Resources

The Company’s working capital position at February 28, 2025 was \$1,349,475 compared to a working capital position of \$1,734,628 at August 31, 2024. The decrease in working capital is mainly due to the change in value of marketable securities and operating expenses.

As at February 28, 2025, the Company had current assets of \$1,360,508 (August 31, 2024 - \$1,775,124), total assets of \$1,360,509 (August 31, 2024 - \$1,775,125) and total liabilities of \$11,033 (August 31, 2024 - \$40,496). At February 28, 2025, the Company had no long-term debt outstanding. There are no known trends in the Company’s liquidity or capital resources.

The Company finances its operations through dividend income. The Company currently has cash and equivalents, marketable securities and short term investments totaling \$1,341,833 and net working capital of \$1,349,475 which, the Company believes, is sufficient to fund its current operations in the foreseeable future. In the longer term, additional equity or debt financing may be necessary to fund exploration, general and administrative activities.

Commitments

Grosvenor has management and consulting contracts with Ian Rozier, a director and Chief Executive Officer, and a company controlled by Tyler Friesen, a director and Chief Financial Officer. The parties are paid a combined total of \$14,000 per month and the contracts remain in force on a continuous basis but can be terminated by Grosvenor with three months written notice. If Grosvenor terminates services of either or both parties without cause, Grosvenor will be obligated

to pay 36 months of service fees to Ian Rozier, and 12 months of service fees to the company controlled by Tyler Friesen.

Effective January 1, 2018, the Company entered into a consulting contract with Prospect Point Consulting Ltd. to provide corporate consulting services for Grosvenor at \$7,000 per month. The contract remains in force on a continuous basis but can be terminated by Grosvenor with three months written notice. If Grosvenor terminates the services of the company without cause, it will be obligated to pay 24 months services fees to the company.

- a) Paid or accrued management fees of \$48,000 (2024 - \$48,000) to Ian Rozier, CEO and director of the Company.
- b) Paid or accrued directors fees of \$6,000 (2024 - \$6,000) to Douglas B. Hyndman, a director of the Company.
- c) Paid or accrued directors fees of \$6,000 (2024 - \$6,000) to Douglas Scheving, a director of the Company.
- d) Paid professional fees of \$36,000 (2024 - \$36,000) to a company controlled by Tyler Friesen, the CFO of the Company.

The following amounts, with respect to the above transactions, are owing to related parties as at February 28, 2025:

- a) \$2,000 (August 31, 2024 - \$2,000) to Douglas Scheving, a director of the Company
- b) \$2,000 (August 31, 2024 - \$2,000) to Douglas B. Hyndman, a director of the Company

These amounts are non-interest bearing, unsecured and paid in the ordinary course of business.

During the six months ended February 28, 2025, the Company reimbursed rent of \$6,000 (2024 - \$6,000), to a company with a director and officer in common.

Financial and Capital Risk Management

Fair value estimates of financial instruments are made at a specific point in time, based on relevant information about financial markets and specific financial instruments. As these estimates are subjective in nature, involving uncertainties and matters of significant judgment, they cannot be determined with precision. Changes in assumptions can significantly affect estimated fair values.

The carrying value of cash and equivalents, receivables and accounts payable and accrued liabilities approximate their fair value because of the short-term nature of these instruments. The fair value of short term investments and marketable securities was \$1,286,563 at February 28, 2025 (August 31, 2024 - \$1,489,165), which are level 1 fair value measurements.

Financial Risk Factors

The Company's Board of Directors has the overall responsibility for the establishment and oversight of the Company's risk management framework.

The Company is exposed in varying degrees to a variety of financial instrument related risks and monitors the risk management processes, inclusive of documented investment policies, counterparty limits, and controlling and reporting structures. The type of risk exposure and the way in which such exposure is managed is provided as follows:

Credit risk

Credit risk is the risk of financial loss associated with counterparty's inability to fulfill its payment obligations. The Company's credit risk is primarily attributable to cash and equivalents, short-term investments and receivables, the carrying value totalling \$1,036,428, represents the Company's maximum exposure to credit risk. Management believes that the credit risk concentration with respect to financial instruments is remote because cash and cash equivalents and short-term investments are held with reputable Canadian financial institutions. Receivables consist mainly of GST and interest. The Company does not consider any of its current receivables past due. The Company believes any credit risk associated with its receivables is low due to the historical success of collecting receivables.

Liquidity risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet liabilities when they come due. As at February 28, 2025, the Company had a cash and equivalents balance of \$55,270, marketable securities of \$429,480 and short-term investments of \$857,083 to settle current liabilities of \$11,033. All of the Company's financial liabilities are subject to normal trade terms.

Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices. These fluctuations may be significant.

a) Interest rate risk

The Company has cash and equivalents balances and short-term investments. The Company's current policy is to invest excess cash in investment-grade short-term deposits certificates issued by its banking institutions. The Company periodically monitors the investments it makes and is satisfied with the credit ratings of its banks. The effect on net loss of a 1% change in interest rates is approximately \$6,300.

b) Price risk

The Company is exposed to equity risk with respect to the market price of its Newport shares. A change in market price will impact the value of its Newport shareholdings and have an impact on other comprehensive income and working capital. The effect on net loss of a 1% change in market price is approximately \$3,100.

Capital management

Grosvenor's objectives when managing capital is to pursue the exploration and evaluation of its mineral property, possibly acquire additional mineral property interests and to maintain a flexible

capital structure which optimizes the costs of capital at an acceptable risk. In the management of capital, the Company includes the components of shareholders' equity.

Grosvenor manages the capital structure and makes adjustments to it, in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Company may issue new shares, issue debt, acquire or dispose of assets or adjust the amount of cash.

In order to facilitate the management of its capital requirements, the Company monitors its expenditures against its available capital.

The Company is currently not subject to externally imposed capital requirements. There were no changes in the Company's approach to capital management.

Risk, Uncertainties and Outlook

As a company engaged in the mineral resource industry, the Company is exposed to a number of risks. As a company engage in the mineral resource industry, Grosvenor is exposed to a number of risks, including the financial risks associated with no operating cash flow and therefore, may access when necessary, the capital markets to finance its activities.

There can be no assurances Grosvenor will be able to access the capital markets for the funding necessary to acquire and maintain exploration properties. In addition to this having an impact on any future wholly owned projects, the Company could be in a position where it is unable to fund its share of costs incurred under a joint venture agreement to which it may become a party, and its interest in such a joint venture could be reduced or eliminated as a result.

Grosvenor is very reliant upon its existing management, and if the services of such personnel were withdrawn for any reason, this could have a material adverse impact on the Company's operating activities.

There is competition within the natural resource industry for properties of merit, and the Company competes with other companies possessing greater technical and financial resources than itself. Even if a property was secured, there can be no assurances that the Company will be able to execute its exploration programs on proposed schedules and within cost estimates, whether due to weather conditions in the areas where it may operate, increasingly stringent environmental regulations and other permitting restrictions, or other factors related to exploring in areas that lack infrastructure and the availability of essential supplies and services. These conditions may lead to increased costs and difficulties in scheduling contractors at times that are optimal from the Company's perspective.

Exploration activities may require permits from various governmental agencies charged with administering laws and regulations governing exploration, labour standards, occupational health and safety, control of toxic substances, waste disposal, land use, environmental protection and other matters. Failure to comply with laws, regulations and permit conditions could result in fines and/or stop work orders, costs for conducting remedial actions and other expenses. In addition, legislation changes to existing laws and regulations could result in significant additional costs to comply with the revised terms and could also result in delays in executing planned programs pending compliance with those terms.

Contingencies
